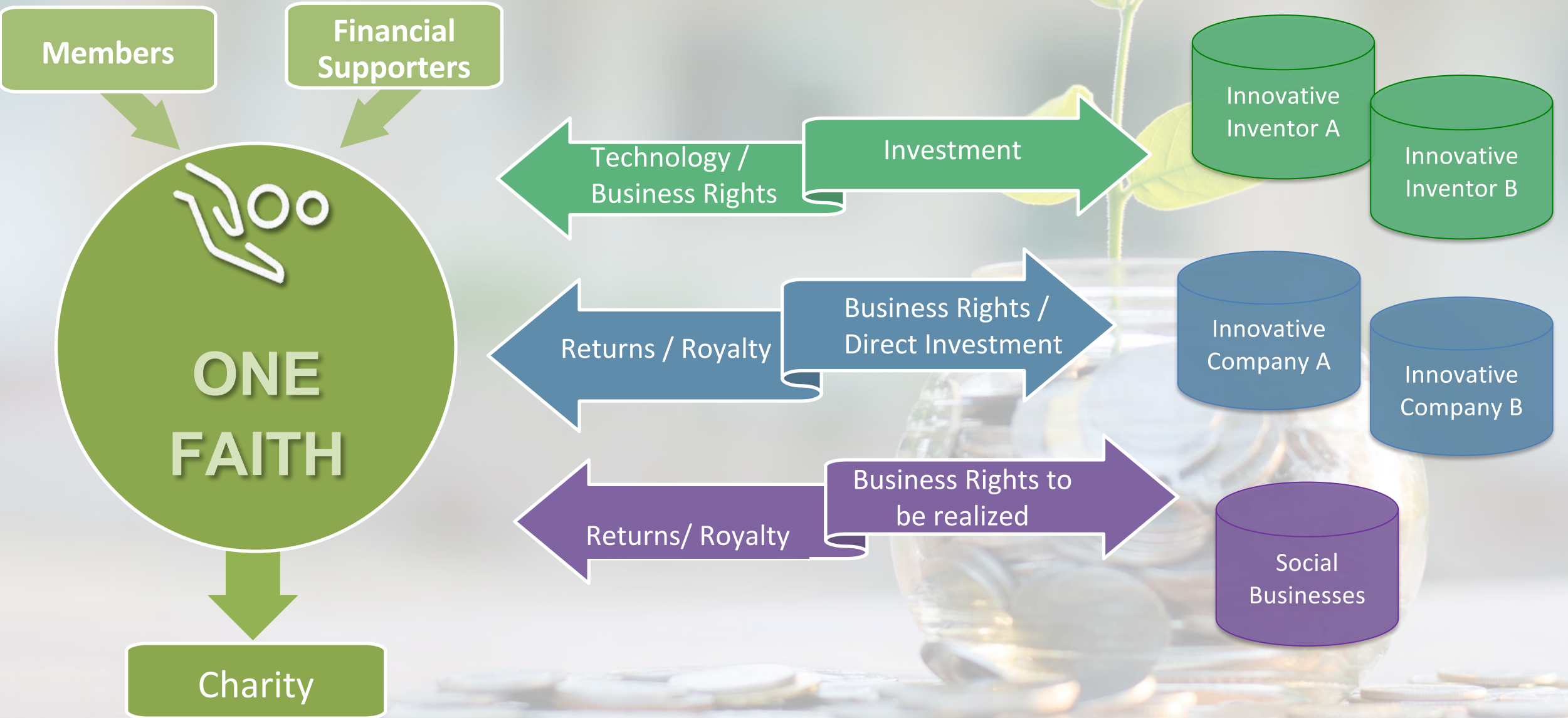

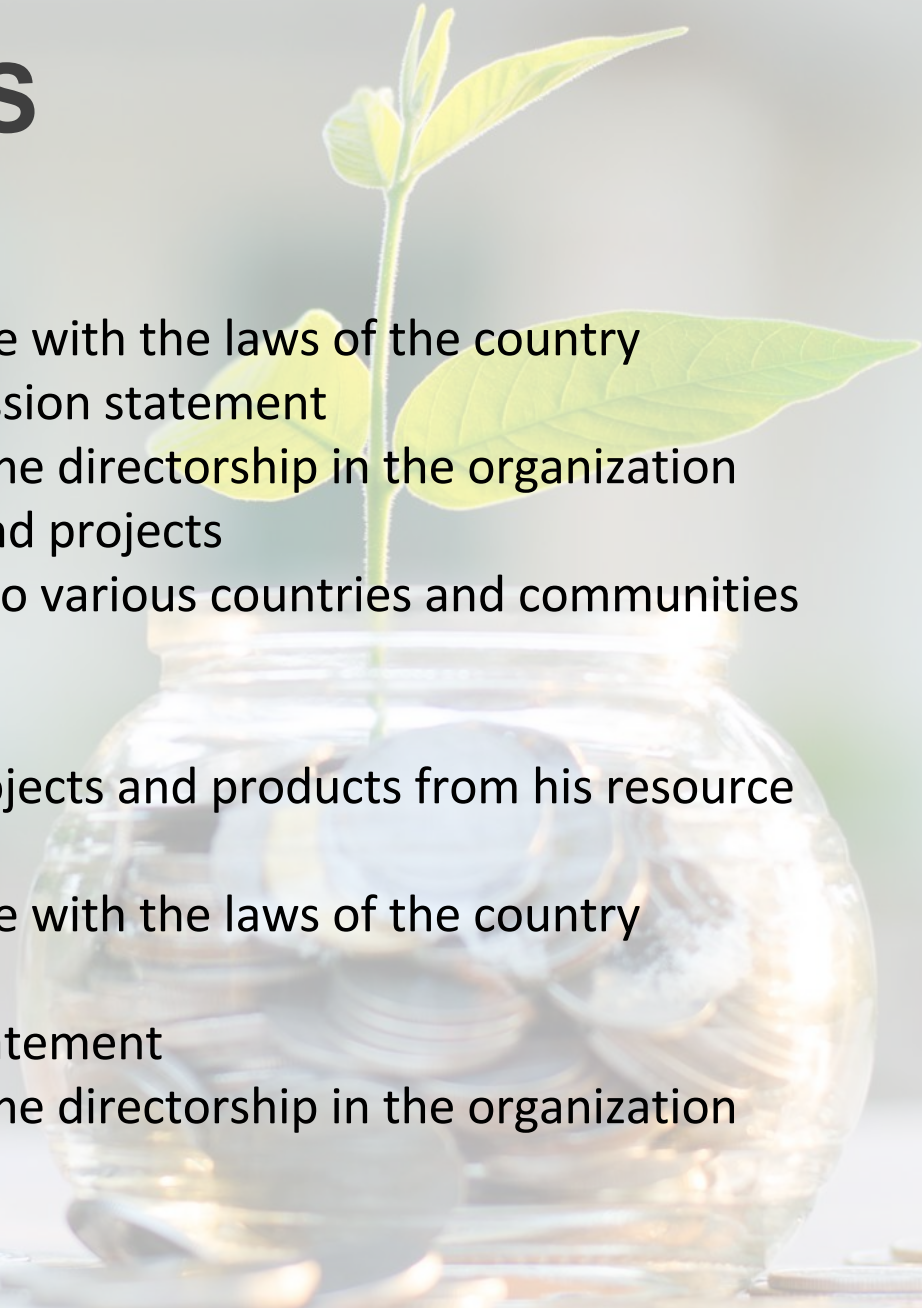
# ROLES & RESPONSIBILITIES

## Founder

- Set and refine policies constantly to achieve the mission statement
- Invites and nominates potential individuals to assume directorship in the organization
- Prepare board meetings to decide on investment and projects
- Promote, arrange or execute programs or projects to various countries and communities

## Co-Founder

- Arrange required funds and planning of the said projects and products from his resource worldwide
- Inherit legal responsibilities construed in accordance with the laws of the country
- Support Founder's activities
- Refine policies constantly to achieve the mission statement
- Invites and nominates potential individuals to assume directorship in the organization



# ROLES & RESPONSIBILITIES



## Director

- Inherit legal responsibilities construed in accordance with the laws of the country
- Invites and appoint potential individuals to assume the role of initiator in the organization
- Provide guidance, communicate and facilitate the initiators.
- Participate in board meetings and resolution passing to decide on investment and projects
- Provide fair and equal opportunities or support to social business groups

## Initiator

- Represent organization as a corporate social responsibility director by name
- Initiators are the most important representatives of the organization because they are the frontiers of projects, products, and campaigns executing the organization's mission statement.
- Facilitate and ensure inventors, companies to follow the same policies set by One Faith Initiative
- Foster development on inventors, companies who are invested by One Faith
- Facilitate and support social businesses One Faith invested on their programs and campaigns
- Communicate constantly with the director/s on updates on the ground activities
